RIM OF THE VALLEY LAND ACQUISITIONS

Wilson Canyon in Sylmar above the Olive View Hospital is a several hundred acre purchase by the Santa Monica Mountain Conservancy, and over 3,000 acres in the Santa Clarita Woodlands on the north facing slope of the Santa Susana Mountains. The latter includes the historic site called Mentryville, which was a small town connected with the first discovery of oil iin California in Pico Canyon - several miles west of I5. There are only three buildings left: a victorian house,

a barn, and an old one-room school house! This was all part of our proposed park back in 1970!

UPDATES

AB 407 needed to be supported with phone calls to Assemblywomen Paula Boland (818) 368-3838 and Assemblyman James Rogan (818) 240-6330. (We need someone to chair a telephone tree committee when these matters come up on short notice.) This is an important bill introduced by Sheila Kuhl to prevent any more new landfills within the Santa Monica Mountains Zone (Rim of the Valley).
